AFFIDAVIT AND UNDERTAKING BY THE PARENT/GUARDIAN

I _____ father/mother/guardian of _____ undertake and do hereby declare on solemn oath that :

- a) My daughter/ward _____ will abide by all the rules and regulations of the University in force or as revised from time to time.
- b) I understand that the fees once deposited shall not be refunded in any circumstances.
- c) I shall personally ensure that my daughter/ward attends the classes regularly, takes the Continuous Assessment Tests, Home Assignments etc. and Semester End Examinations in right earnest, puts in regular attendance in all papers / practicals / projects etc. participates in the curricular and extracurricular activities and does not, in any way, violate the norms of University discipline.
- d) The University fee and other dues, as in force or revised, will be paid regularly and on time.
- e) No early departure from the University will be permitted, unless it has the approval of the University authorities.
- f) I shall personally ensure that my daughter/ward maintains perfect discipline and abides by the orders issued by the University authorities. I shall be personally responsible for her conduct and discipline in the University.
- g) In the event of any change in rules & regulations or syllabi and books made by the University statutory bodies, my daughter/ward shall, except in so far as the University determines otherwise, comply with the change(s) that applies to the year(s) she has not completed at the time of the change.
- h) She has not been found guilty of any unfair practice in the Board/University examination.
- i) My daughter/ward _____ has not been convicted of any criminal offence nor has been released on bail in connection with a criminal case. No case of criminal offence or moral turpitude is pending against her in any court of law.
- j) She has not resorted to any act of indiscipline during the previous years.
- k) If she does not satisfy eligibility rules of admission and if any information given by me/her is found to be false, her admission will stand cancelled.
- l) If she is not found eligible for admission by the University her admission will automatically stand cancelled.
- m) She may be refused admission or if admitted, her admission will stand cancelled, if any of the certificates submitted by her are, at any stage, found to be forged or false, and IIS (deemed to be University) will be free to take further disciplinary action against her and the fees deposited by her shall stand forfeited.
- n) She will not be allowed to sit for the Semester End Examinations if she falls short of the required attendance or does not take the CA test or if her progress in studies is not adjudged upto the mark.

- Any candidate (who has been granted provisional / final admission to any course in the University) not desirous of continuing her admission after deposition of fees (laboratory fees, security deposit and conveyance charges etc.) will be entitled for refund of security deposit only subject to notice / information having been given in writing by the candidate within 15 days from the date of deposition fees. Other amount of fees is non-refundable. The decision of the management in this regard shall be final and binding in all cases.
- Ragging is an offence. It is strictly banned in IIS (deemed to be University) as per the Supreme Court directives. Strict disciplinary action shall be taken against those students who are found involved in ragging. It may lead to suspension, rustication or even expulsion from the University.
- The students are not allowed to carry and use mobile phone on campus. This must be strictly followed, failing which the mobile phone may be confiscated and the students penalized with a heavy fine.
